
This order is issued upon the receipt of the Withdrawal of Certificate of Non Compliance from the Iowa Department of Revenue (IDR) requesting a withdrawal of its request to sanction the license of Respondent.

By Order issued November 18, 2015, the Board indefinitely suspended the Respondent's teaching license. Pursuant to Board rule 282 I.A.C. 11.34, any person whose license has been suspended "may apply to the board for reinstatement in accordance with the terms and conditions of the order of the suspension."

ORDER

THEREFORE, the Board hereby orders that the indefinite suspension of Respondent's license is lifted. Mr. Bannister's license is hereby reinstated.



YOU ARE HEREBY NOTIFIED, PURSUANT TO IOWA CODE SECTIONS 272D.8, 272D.9 and 282 IOWA ADMINISTRATIVE CODE (IAC) CHAPTER 8, THAT:

1. The Iowa Board of Educational Examiners intends to suspend your teaching license due to the Board's receipt of the certificate of non compliance from the Iowa Department of Revenue (IDR).
2. You must contact the IDR at the address or phone number in the certificate of non compliance to schedule a conference or otherwise obtain a withdrawal of the certificate of non compliance.
3. Unless the IDR furnishes a withdrawal of the certificate of non compliance to the Board within thirty (30) days of the issuance of this notice, your license with the Board will be suspended.
4. Pursuant to 282 IAC 8.2(2), the effective date of the suspension of a license, as specified in the notice required by Iowa code section 272D.8, shall be sixty (60) days following service of the notice upon the licensee or applicant.
5. Pursuant to 282 IAC 8.2(4) you are required to keep the Board informed of all court actions and all actions taken by the IDR by providing copies to the Board within seven (7) days of filing or issuance, of all applications filed with the district court pursuant to Iowa Code section 272D.9, all court orders entered in such actions, and withdrawals of certificate of non compliance by the IDR.
6. You do not have a right to hearing before the Board, but you do have the right to contest this Notice by requesting a court hearing pursuant to Iowa Code section 272D.9, within thirty (30) days of service of this Notice.
