1. This form is to be used only if you currently have an Initial License and will qualify for a Standard License within one more year. If you are unsure of what type of license you hold, please go to our web site at [www.boee.iowa.gov](http://www.boee.iowa.gov) and click "search for a license".
2. The fee is \$25. Send this complete application and check or money order (made payable to Board of Educational Examiners) to the **Board of Educational Examiners, Grimes State Office Building, 400 E. 14<sup>th</sup> St., Des Moines, IA 50319-0147.**
3. **LATE RENEWAL FEE.** An additional fee of \$25 per calendar month, not to exceed \$150, shall be imposed if a renewal application is submitted after the expiration date of the Initial License.

\*Public School Teacher – Use this form only if you have one year of PK-12 experience as a contracted teacher and will have the two years experience within one year.

\*\*Nonpublic School Teacher – Use this form only if you have two full years of PK-12 experience as a contracted teacher and will have the three years experience necessary to convert to the Standard License within one more year.

If you have taken any college credit or licensure renewal credit before the issue date of the Standard License, these hours cannot be used to renew a future standard license.

Name changes require a photocopy of official legal documentation such as a photocopy of a driver's license or marriage license.

All fees are **NONREFUNDABLE**. Incomplete applications will be voided after 45 days.
