WE WANT TO DO AN EXCELLENT JOB FOR YOU. HERE IS HOW YOU CAN HELP:

1. To renew a substitute teaching license, provide either verification of at least 30 days of substitute teaching during the term of the license (or no more than five years old), one year of teaching experience within the last five years completed during the term of a valid Iowa teaching license, or transcripts showing the completion of one semester hour of credit earned during the term of the license (after the issue date and before the expiration date) or no more than 5 years old taken from either a regionally accredited college or AEA license renewal credit.
2. Continuing education units (C.E.U.s) are not accepted for renewal.
3. Include a copy of the certificate verifying completion of the **child and dependent adult abuse mandatory reporter training** if you are currently serving in an Iowa School system **or** if you have an Iowa address. The mandatory reporter training is waived if you do not have an Iowa address **and** you are not serving in an Iowa school.
4. The application packet must include a completed application, \$86.00 application and background check fees, and a transcript or verification of substitute teaching. All fees are NONREFUNDABLE.
5. Send all materials and check or money order (made payable to the Board of Educational Examiners) to the **Board of Educational Examiners, Licensure, Grimes State Office Building, 400 East 14th St., Des Moines, IA 50319-0146.**

All fees are NONREFUNDABLE. Incomplete applications will be voided after 45 days.
