SUBJECT: Information concerning transcript or credential evaluation for individuals with teacher preparation outside of the United States.

The State Board of Educational Examiners does not have the resources to determine degree and course credit equivalencies from outside the United States or to translate foreign credentials or transcripts. The rules for licensure require persons with preparation from outside of the United States to work with some agency or institutions to obtain an appropriate assessment of the credentials/records in terms of degree and course credit equivalencies and translation of course titles. This office will use the assessment to determine if the appropriate degree and course requirements have been met for Iowa teacher licensure purposes. PLEASE SUBMIT THE COURSE BY COURSE EVALUATION REPORT FROM THE AGENCY.

OUT-OF-COUNTRY APPLICATION FOR LICENSURE CHECKLIST

Incomplete applications will delay processing. Please double check:

- Have you completed section I?**

- Have you sent your transcripts to an approved transcript evaluation service, and are you enclosing the results of their analysis with this application?**

- Have you enclosed your check or money order which includes the evaluation and processing fees (\$60) and the fee for issuance of the license (\$85)?**

- Have you verified sufficient teaching and administrator experience?**
(-An Initial License does not require verification of experience.)
(-At least three years of teaching experience are necessary to qualify for a Standard Teacher License or an Administrator License.)
(-five years of teaching experience (and a master's degree) are necessary to qualify for a Master Educator License.)
(-Three years of administrative experience are necessary to qualify for a superintendent endorsement.)
(-If you completed an alternative teacher education program which did not include student teaching, you must verify three years of teaching experience.)
You may use our form or a letter from an administrator in the employing school district on school letterhead stating the nature, and dates of your assignment.

- Have you enclosed, or sent separately, your completed fingerprint card and waiver form, and the \$65 background check fee? (This fee and the fees for the processing and license may be combined in a single check or money order.)**
If you need a fingerprint packet, call (515) 281-3245 to leave your name and address and request a fingerprint packet. The packet will be mailed on the same or next business day.

Requirements for Licenses

Initial Valid for 2 years. – Renewable under prescribed conditions.

1. Baccalaureate degree from a regionally accredited institution.
2. Completion of an approved teacher preparation program.
3. Completion of an approved human relations component.
4. Completion of requirements for a teaching endorsement.
5. Meets the recency requirement listed under the Class A License.

Standard Valid for 5 years. – Renewable under prescribed conditions.

1. Completion of requirements 1-4 for the initial license.
2. Evidence of three years successful teaching experience based on local evaluation process.
3. Meets the recency requirement listed under the Class A License.

If applying for this license, verify 3 years of teaching experience.

Master Educator Valid for 5 years. – Renewable under prescribed conditions.

1. Hold or be eligible for an standard license.
2. Five years of teaching experience.
3. Master's degree in a teaching endorsement area.
4. Meets the recency requirement listed under the Class A License.

If applying for this license, verify 5 years of teaching experience and send master's degree transcript.

Class A Valid for 1 year. – Not Renewable. Issued under the following conditions:

1. Has completed a teacher education program but may still need some classes to meet all of Iowa's requirements for licensure (e.g. Foundations of American Education.)
2. Recency -- meets requirements for a valid license but has neither 160 days of teaching experience nor six hours of relevant college credit within the past five years.

The applicant must meet any and all licensure deficiencies during the one-year period of the license.

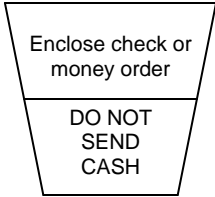
Substitute Valid for 5 years. – Renewable under prescribed conditions.

Has been the holder of, or presently holds a valid, regular license in Iowa or some other state and has successfully completed all requirements for an approved teacher preparation program or is eligible for the initial license.

Exchange Valid for 1 year. – Not renewable.

1. Baccalaureate degree from a regionally accredited institution.
2. Completion of a state approved teacher preparation program.
3. Hold a valid teaching license in the state in which the teacher preparation program was completed.
4. No disciplinary action pending.
5. Has not completed all Iowa requirements for a teaching endorsement.

The applicant must meet any and all licensure deficiencies during the time frame of the license.
